# California Green Collar Jobs Council

---

- Formed by legislation in 2008

- Fosters development of regional strategies to grow California competitiveness

  - **R**ecycling existing materials
  - **E**nergy efficient product manufacturing, distribution, construction, installation, and maintenance
  - **E**ducation, compliance, and awareness
  - **N**atural and sustainable product manufacturing

---

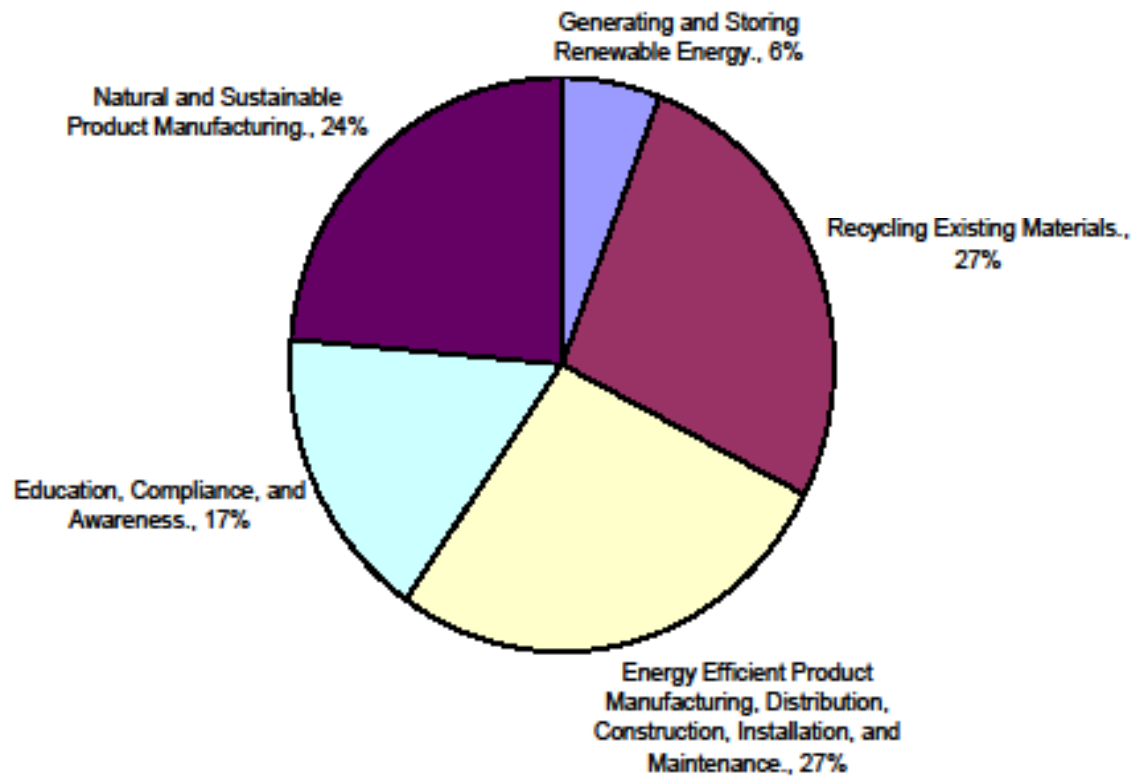
- Most green jobs:
  - 300,000 full time green jobs
  - 171,000 jobs with green components
  - 3.8% of all California employment
- Most green businesses:
  - 130,000 business establishments
- Most venture capital investing:
  - \$3.3 billion
  - 57% of U.S. capital funding

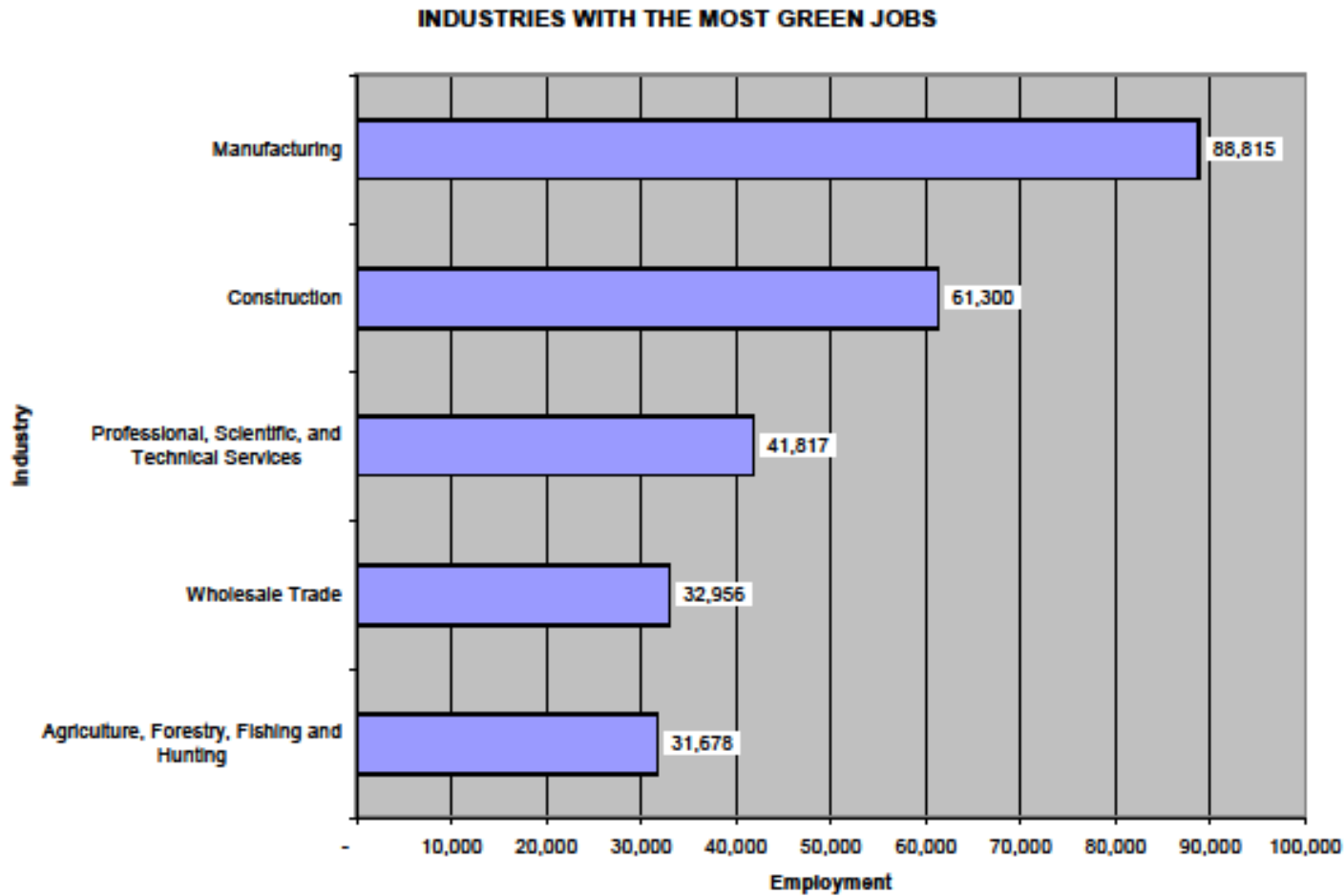
PERCENTAGE OF EMPLOYEES IN GREEN CATEGORIES

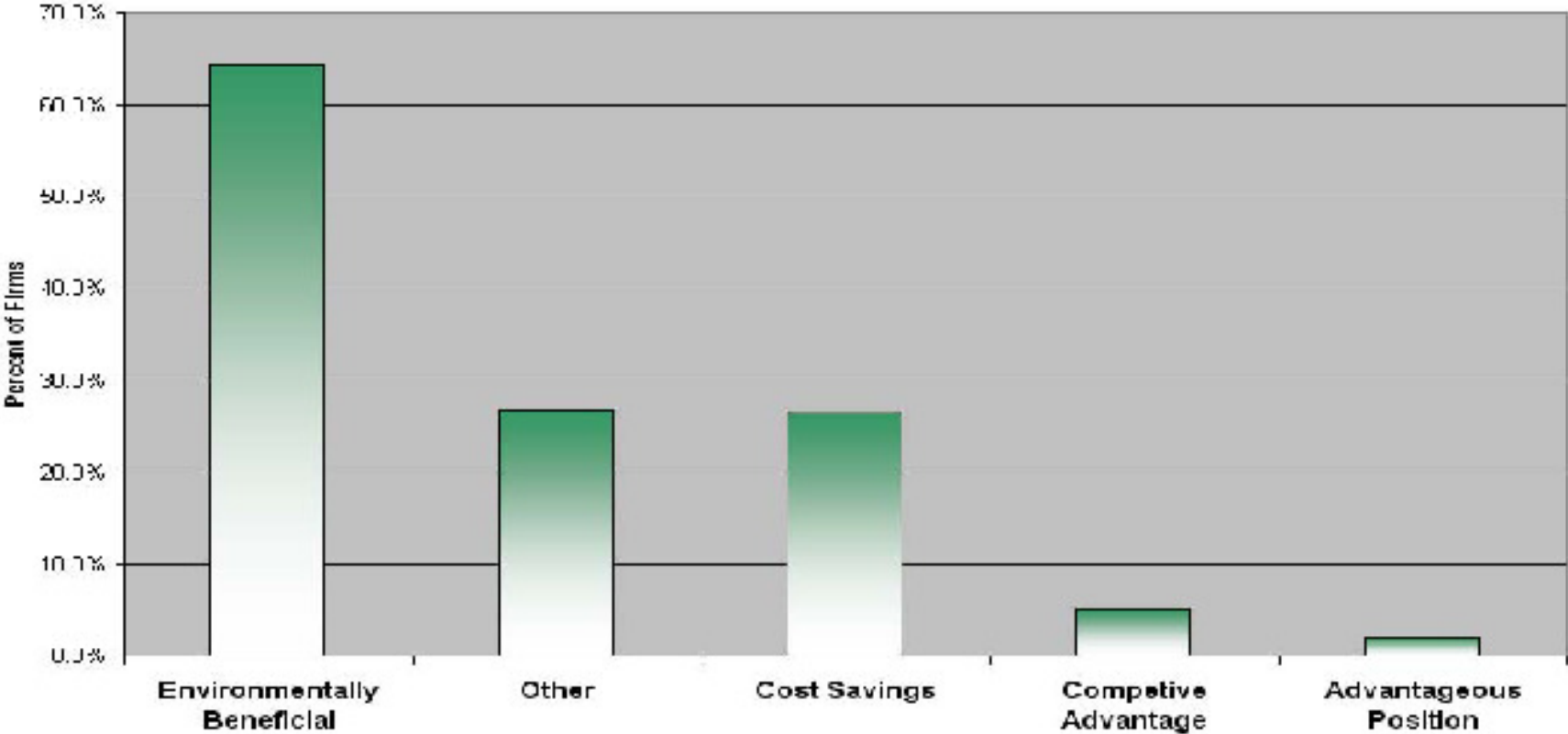

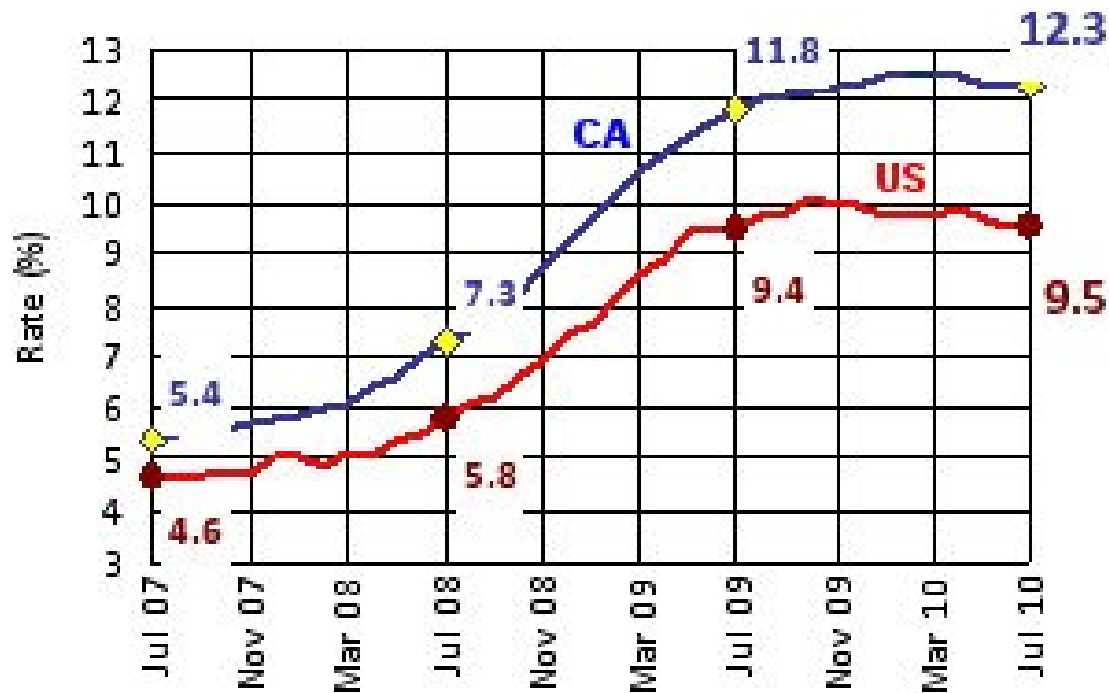

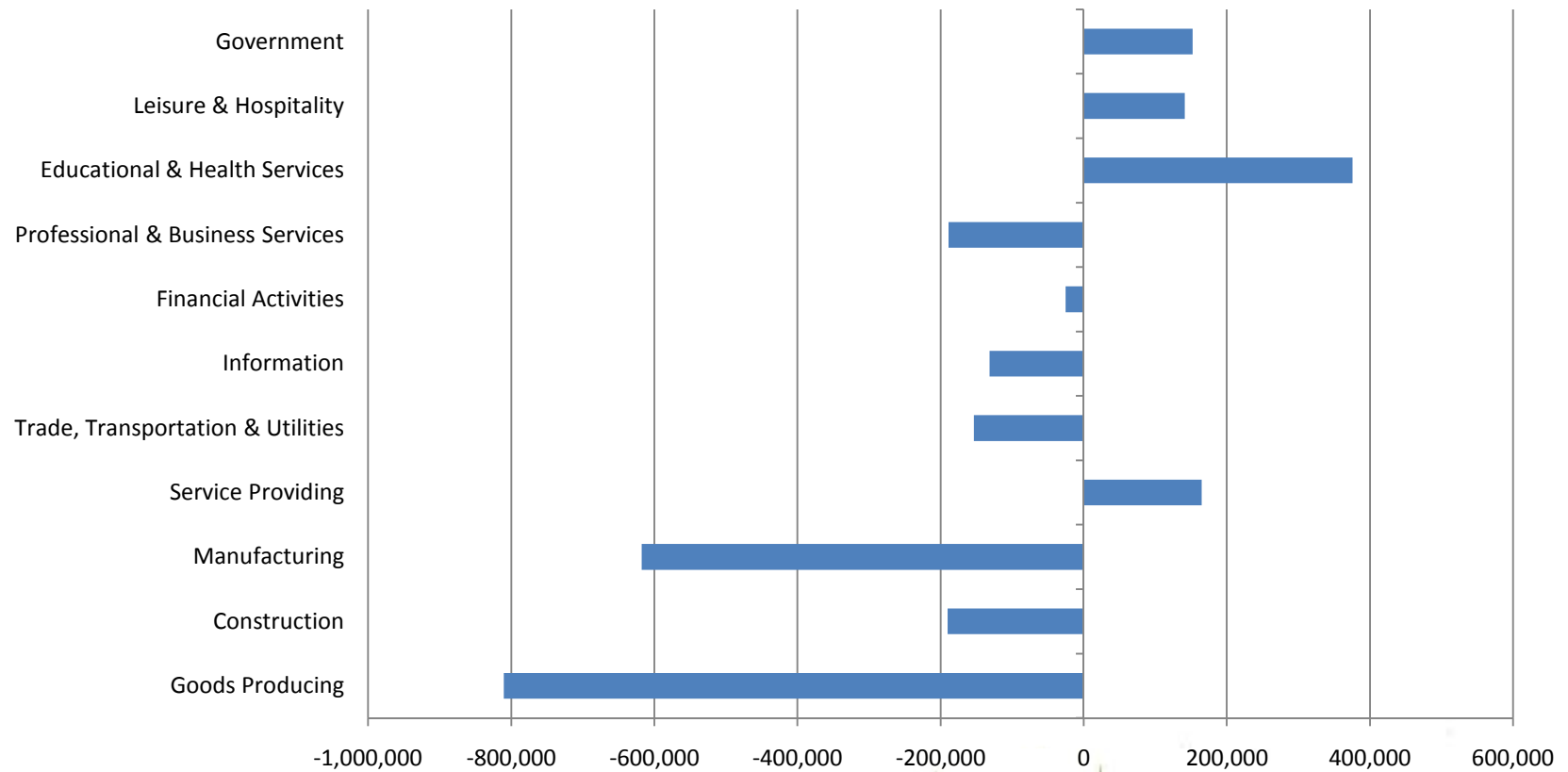
# Our Biggest Challenge

# The Green Job Prescription for California

---

- California's economy is too big for new green industries to replace overall job losses and job needs from added population.
